

Instructions

1. Maharaja Suhel Dev State University, Azamgarh invites online applications from eligible citizens of India to fill up the following Teaching Positions on direct recruitment basis in the given pay scale.

Position Name	Pay Scale (As per 7 th CPC)
Professor	Level 14 (Rs.1,44,200/- to Rs.2,18,200/-)
Associate Professor	Level 13A (Rs.1,31,400/- to Rs.2,17,100/-)
Assistant Professor	Level 10 (Rs.57,700/- to Rs.1,82,400/-)

2. Minimum eligibility and qualifications for each position shall be in accordance with the UGC Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, Regulations 2018 (here in after referred to as UGC Regulations, 2018) published in the Gazette of India (No. 271, dated 18 July 2018)/UP Govt GO. No. 800/sattar-1-2019-18(114)/2010, dated 28 June 2019/GO NO. 1190/sattar-1-2019-16(114)/2010, dated 15 October 2019.
3. Candidates working in Govt./Semi Govt./Public Sector Undertaking/Autonomous Institutions, etc. are required to submit their applications through proper channel.
4. Only shortlisted candidates will be called for interview.
5. The desirable discipline in case of Integrative Science shall be Bioinformatics.
6. In the process of appointment, wherever applicable, the provisions stipulated in the Governor's Secretariat, U.P. order संख्या ई-3019/32-जी0एस0/2020 दिनांक 18 मई 2021, संख्या-ई-4229/जी0एस0, दिनांक- 02 जुलाई, 2021 and पत्रांक -ई-5862 /जी0 एस0 dated 03 September, 2021 shall also be followed.
7. Applicant must fulfill the prescribed essential qualifications and experience for a given post.
8. Complete application, in all respects, shall be submitted through online mode latest by **23 September 2024** and hard copy of the application form shall be submitted through speed/registered post with all self-attested documents. So as to reach the Registrar, Maharaja Suhel Dev State University, Azamgarh- 276128 latest by **30 September 2024**. The applications received after due date/incomplete application/not duly signed/without application fee/without attested copies of the certificates/educational qualifications/experience (Academic Research Score Chart) or not in the prescribed Proforma will not be considered.
9. **The candidates who have applied for any teaching post against earlier advt. no. 01/2024 need not to apply again. However they can update their application for any change in their academic qualifications, etc. and resend the updated application form along with the updated record.**
10. The name of the Post and Subject must be mentioned on top of the envelop.
11. Separate application along with application fee must be submitted for each position applied for.
12. The prescribed minimum qualifications and experience are for eligibility and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview. The

University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of academic score which may be higher than the minimum prescribed qualifications as decided by duly constituted Screening Committee(s) and approved by Competent Authority. The recruitment process can be cancelled/suspended/terminated without assigning any reasons and the decision of the University will be final and no appeal will be entertained.

13. The Maharaja Suhel Dev State University, Azamgarh reserves the right:

- (a) To Increase/decrease the number of positions at the time of interview/selection and make appointments accordingly.
- (b) To fix criteria for short-listing the applications/applicants.
- (c) To raise the standard of specifications for restricting the number of candidates to be called for Interview.
- (d) To withdraw the advertisement either partly or fully at any time without assigning any reason.
- (e) To fill or not to fill up some or all the positions advertised without assigning any reason.
- (f) To draw up reserve panel/waiting list(s), which will be valid for one year either from the date of approval of the competent authority or before the next advertisement.
- (g) To alter/insert any corrections/additions in the advertisement on the website, if required, before the last date prescribed for the receipt of applications.
- (h) The Selection Committee may decide its own method of evaluating the performance of the candidates in interview, where method of recruitment is interview alone.
- (i) In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of appointment letter, the University reserves the right to cancel the appointment and communicate the same to the candidate.

14. **Submission of Application Fee:** Application must be accompanied with a non-refundable application fee of Rs. 2000/- for UR/OBC and Rs. 1500/- for SC/ST/EWS/DA category for each position. Application fee will be paid through online mode only. Application fee once paid will not be refunded under any circumstances. Attach the Copy of receipt of Application fee paid through online.

15. Reservation Policy will be followed as per Government of U.P. Rules.

16. Person suffering from not less than 40% of the relevant disability shall only be eligible for the benefit of the reservation for Divyang/DA category.

17. The SC/ST/OBC (Non-creamy layer)/DA/EWS candidates are required to attach necessary certificate(s) (Self-attested copy) as prescribed by the Government of Uttar Pradesh. The benefit of reservation will be applicable to the resident of Uttar Pradesh Only. The candidates must attach the domicile certificate if would like to avail the benefit of reservation. At any stage, if it is

found that the certificate is not valid, the candidature shall stand cancelled and appointment made, shall be terminated with immediate effect alongwith recovery. Candidate belonging to OBC in creamy layer will not be entitled to the benefit of reservation and shall have to apply as Unreserved Category (UR) candidate.

18. The candidate must enclose the Income tax return statement and salary slip of last three years if already employed in public/private sector.
19. A relaxation of 5% shall be allowed at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
20. A relaxation of 5% shall be provided from 55% to 50% of the marks to the Ph.D. degree holders who have passed their Master's degree prior to 19th Sept. 1991, wherever applicable.
21. Candidates applying for the position of Professor and Associate Professor are advised to satisfy themselves before applying that they possess the minimum Research Score, as per UGC/AICTE Regulation as applicable. Such candidates are required to submit the attested copies of their appointment letter, joining letter and proof of the pay scale and grade pay for their previous and present post/posts held as claimed for teaching experience.
22. For the position of Professor, minimum one successful Ph. D. research guidance (awarded) is essential. The proof (certificate) from the university in respect of the successful research guidance (Ph.D.)/ M. Phil. guidance/ P G dissertation guidance etc. should be attached along with the application form.
23. A candidate who is already in service (working in Govt. Department, Autonomous bodies application for along with Public Sector Undertakings, Universities etc.) shall submit their printed/downloaded application along with "Through Proper Channel" and with 'Vigilance Clearance Certificate from the competent authority. However, any application deposited without proper certificate, due to whatever reasons, the candidate must submit them at the time of interview.
24. Provided that if "No Objection Certificate" from the employer is not produced at the time of interview, candidature of the candidate may be considered for direct recruitment as a fresh candidate, if otherwise eligible.
25. The selected candidate shall produce a medical certificate from the Medical Board issued by a Govt. hospital/or Govt./CGHS empaneled hospital, at the time of his/her joining.

26. The period spent by the candidates to acquire M.Phil. and/or Ph.D. Degree will not be considered as research experience.
27. As per the UGC guidelines dated 21st September 2016, "If the M.Phil./Ph.D. degree of any candidate is awarded by a Foreign University, the University shall refer the same to a Standing Committee constituted for the purpose of determining the equivalence of the degree awarded by the foreign University".
28. There shall be written test for Assistant Professor post. A test of teaching skill shall be conducted from the shortlisted candidates through power point presentation at the time of interview. The research score will be published on university website. The candidate has to submit the objection in the research score (API) if any, within seven days (07) from the date of publication on university website (संख्या-ई-4229/जी0एस0, दिनांक- 02 जुलाई, 2021 एवं संख्या ई-3019/32-जी0एस0/2020 दिनांक 18 मई 2021) राज्यपाल सचिवालय उत्तर प्रदेश, लखनऊ-226027 तथा पत्रांक -ई-5862 /जी0 एस0 दिनांक 03 सितम्बर, 2021)
29. No T.A./D.A. will be paid to the candidates appearing for the interview.
30. The candidate who is appointed against any position in the University shall be governed by the provisions of Act/ Statutes/ Ordinances/ Rules of the University or any other Rules of the Government of U.P, as amended from time to time or and any other rule/resolution prescribed specifically for maintaining the conduct of the employee by the Executive Council of Maharaja Suhel Dev State University, Azamgarh. The University shall be free to assign any duty as per the exigency of the situation at any time even during non-working hours/holidays which the employee shall have to perform without fail to avoid any disciplinary action.
31. The service conditions including Pay Level and age of superannuation shall be as per Government of Uttar Pradesh/ UGC rules.
32. The candidates selected shall be appointed under a written contract on probation for a period of one year extendable by one more year if required as prescribed by the Act, Statutes and Ordinances of University.
33. The candidates selected for appointment are expected to join within three months from the date of announcement of results.
34. Information uploaded on the Maharaja Suhel Dev State University, Azamgarh website <https://msdsu.ac.in> shall not be provided to the candidate under RTI Act, 2005. The uploaded information on the Maharaja Suhel Dev State University, Azamgarh website shall remain for a specific period only. Therefore, the candidates are advised to download the information and keep them for future reference. In the process of recruitment neither any application under Right to Information Act, 2005 shall be entertained nor any information shall be provided. Factual information under RTI Act shall be provided only after declaration of final result.
35. Candidates must write their E-mail ID neatly and correctly for mailing interview/appointment letter as attachment. The E-mail date will be considered as the official date of dispatch and receipt of communication. Candidates not having an E-mail ID must create an ID and check it regularly for further communication.

36. Call letters to attend the interview will be sent only to the shortlisted candidates by Email, speed post or registry only. No Correspondence will be made with applicants who are not short-listed/not called for interview. Therefore, the candidates are advised to check the Maharaja Suhel Dev State University, Azamgarh website and their Email regularly.
37. The following categories of persons shall not be eligible to apply for any position in the Maharaja Suhel Dev State University, Azamgarh:
- Who is not a citizen of India;
 - Who has been convicted by any Court of Law or if any criminal proceedings are pending against him.
 - Who has entered into or contracted a marriage with a person having a spouse living.
 - Any other category of person disqualified for appointment by the Government of U.P/UGC from time to time, will not be considered for appointment.
 - Who is not of sound mind.
38. In case of unsatisfactory performance, misconduct or on ground of misbehaviour, the appointing authority may at its discretion extend the period of probation by one year. In case there is no perceptible improvement, despite all this, his/her services shall be terminated by giving one month's notice or on payment of one month's salary in lieu of notice. During probation, the employee concerned may also exercise his/her option to quit by giving one month's notice or deposit one month's salary in lieu of notice.
39. No objection certificate for outside employment shall not be forwarded during the period of probation.
40. Regarding any ambiguity or lack of clarity in any clause or lines, the decision of the Maharaja Suhel Dev State University, Azamgarh shall be final.
41. In case of any disputes, any suits or legal proceedings against the Maharaja Suhel Dev State University, Azamgarh, the territorial jurisdiction shall be restricted to the Court of Azamgarh District/Allahabad High Court (U.P) only.
42. No correspondence or telephonic/electronic query will be entertained from candidates regarding conduct and result of interview and reasons for not being called for interview, etc.
43. The appointment of candidates on regular basis shall be governed by national pension scheme (NPS) (applicable on organizations established on or after 01.04.2005) and as such employees coming from pensionable establishments would be governed by pension scheme of the parent department till such time, they retain lien with the parent organization.

- The application form duly filled in the prescribed format along with required documents must reach the Registrar, Maharaja Suhel Dev State University, Azamgarh, U.P. 276128 through Registered/Speed Post on or before 30 September 2024 by 5.00 P.M., mentioning the name of post and the name of Department/Subject on the envelop. Candidate must mention the name of post applied for and Subject on the envelope.
- Addendum/Dedendum/Corrigendum/notices to this advertisement, if any, shall be published on the Maharaja Suhel Dev State University, Azamgarh website <https://msdsu.ac.in> and will also be published in the newspapers. Therefore, candidates are advised to check the Maharaja Suhel Dev State University, Azamgarh website regularly.
- The eligibility of the applicants will be determined on the basis of the last date of submission of the application form.
- Mere eligibility will not entitle any applicants to be called for interview.
